Pitch and Putt Ireland is the National Governing Body for Pitch ad Putt in Ireland. Pitch and Putt Ireland provides various Pitch and Putt activities and opportunities for young people through participation in clubs, regional, provincial events and through our national events.

Section 2 - Pitch and Putt Ireland is committed to safeguarding children and by working under our Safeguarding Policies. Our staff, both volunteers and employed, working with our young people, throughout the organisation, seek to create a safe environment for young people to grow and develop within our sport, by adhering to the following principles:

- 1. **Importance of childhood** The importance of childhood should be understood and valued by everyone involved in pitch and Putt
- 2. **Needs of the child** All children's Pitch and Putt experiences should be guided by what is best for children. This means that adults should have a basic understanding of the emotional, physical, and personal needs of young people
- 3. **Integrity in relationships** Adults interacting with children in Pitch and Putt are in a position of trust and influence and they must never abuse this position of trust. They should always ensure that children are treated with integrity and respect, and the self-esteem of young people is enhanced
- 4. **Fair Play** All children's Pitch and Putt should be conducted in an atmosphere of fair play. The principles of fair play should always be emphasised, and organisers should give clear guidelines regarding acceptable standards of behaviour
- 5. **Quality atmosphere & ethos** Children's Pitch and Putt should be conducted in a safe, positive, and encouraging atmosphere.
- 6. **Competition** Competition is an essential element of Pitch and Putt and should be encouraged in an age-appropriate manner. A child centred ethos will help to ensure that competition and specialisation are kept in their appropriate place.
- 7. **Equality** All children should be valued and treated in an equitable and fair manner regardless of ability, age, gender, sexual orientation, religion, social and ethnic background, or political persuasion.
